 rigs. Engine11's Auxiliary primer for the pony motor has yet to be figured
 out/fixed. Looking to contact the previous mechanic who worked on this for us,
 it may require sending it out for a while for repairs. Hoping to get as many
 repairs as possible with Bowman's.
 - Board says to have Bowman's finish what they can and find out where we took it last time and send it on its way for repair.
 - B311's pony motor needed to be refueled three times during Monday's fire. ZFD would like to add a 5-gallon fuel can, to keep the apparatus in service. Board says this needs to be addressed.
 - Two filters have been ordered from Canevari Bros
 - Need to purchase an ice chest for Squad11, it's a must for medical aid calls during the summer.
 - Chief's rig finally has a quote on stickers. SignWorx estimates \$1,389.04, plus tax.
 This type of work cannot be done onsite, it would have to be sent to their shop.

 the estimated amount of \$1,389.04, plus tax.
