- 2. Fire Chief Report (to include any Yolo County Fire Chief's Association report and any actions requested/taken from the Zamora Fire Volunteer Department or the Zamora Firehouse); (Chief's report is allotted 15 minutes)

Chief Covington Reports:

- -ZFD will be hosting a fundraiser on May 15th with a "grab & go" style dinner -He's drafted ZFD's Strategic Plan which covers their 2 and 5-year plan/goals on how the Department will use the Proposition 172 funds along with an apparatus replacement plan.
- -ZFD bought parts for water tender repairs. The Department voted to purchase these regardless if ZFPD would reimburse them, but brought an invoice for parts purchased to see if they can be reimbursed. The water tender has not been fixed; the valves need to be coated to prevent electrolysis. Should we get them coated? Board says to spray them to prevent this.
- -ZFD has registered with the County as a vendor so reimbursement it possible.
- -Volunteers have been curious about life insurance policies; If something were to happen to a volunteer on a call, they would want their families taken care of. Board requests DSLC to contact Golden State Risk Management Authority to get more information.
- -Will look into getting quotes for a "First Response" vehicle for the Department and hope to prepare this before the new fiscal year budgeting. They'd like to get one previous used by CalFire as it would come equipped with the basic necessities.
- -Assistant Chief, Travis Teague is still looking for a contractor to work on the Firehouse ceiling
- -Assistant Chief is curious if he can get a regular update on the budget to see where they stand with their expense accounts budgeted at the beginning of the fiscal year.
- -They have a hose with a couple burnt spots on the back.
- -Volunteers noticed dash cluster in the squad is going down and the oil needs changing. Board says to get it fixed, this is general maintenance, call Bowman's Auto Repair.

- -Engine 11 got a tire fixed
- -Firehouse door needs fixing or replacing.
- -AT&T wants to switch over to digital fiber for landline. They say it would come with internet and the bill would be cheaper with this switch, but no update on when this will happen.
