The meeting was called to order by Commissioner/ Chair Doug Lewey at 7:00 PM.

Input/Open forum Public (to include any discussions and/or actions needed/taken regarding the town hall):

Zamora Fire Volunteers discuss updates on recent quotes for gear and services.

Mr. Justin Gwerder notes that they have recently been quoted for new turnouts, helmets, face shields, boots and gloves from Cascade Fire Equipment. They only plan to purchase what the volunteers needed new. Cascade Fire Equipment quoted \$20,296.98

- -SCBA's need flow testing and the volunteers need fit testing. Cascade representative, Kevin, can provide both in the same day and provide a combo rate. These tests are to be done yearly and must be done. Cascade quoted the ZFD for this service at \$1,415.00. The ZFD will be creating a yearly cost sheet to provide to The Board and DSLC for budgeting.
- -Medical bags need updating and Mr. Gwerder provided a list of necessary items to be purchased. Although ZFD is not medically trained, they are all getting more CPR training.
- -It is important that Narcan Medical bags and refrigeration are included as well.
- -After sharing their business, Justin Gwerder, Chase Covington and Greg Giguiere, left the meeting.
- -Commissioner Richard Covington updated the Board on the most recent Rabaino Roofing quote after adding a vent and roof color. The Board would like to get another quote for the Firehouse roof and table this quote until then.

After Board discussion of the newly supplied quotes for turnouts Commissioner Cathy Gwerder motions that if the Zamora Fire Department will pay \$8,000.00 towards turnout costs, the ZFPD will pay the remaining balance of \$12,296.98

Chief Moore reports:

- -The Volunteers have stepped it up in responding to calls and are making all of them before Yolo Fire responds.
- -The training has improved as well
- -Gearing up the Department is most important to him and wants the guys to be safe when they respond to calls. The ZFD are still learning all newly updated safety guidelines to abide by and put into action.
- -An IPP plan is top priority as well and measures need to be taken to complete this.
- -Received a call for pressure tests on hoses. This is supposed to be conducted yearly. The company is offering their services to test hoses for ZFD.
- -ZFD is trying to create a list so we have the yearly services in the budget so nothing is unexpected or over budget.
- -Cascade representative helped with turnout fittings at the firehouse.
- -Looking into grants for a generator. Would be great for filling trucks when power is out.
- 3. Discuss and possibly take action on removal of diseased tree of Zamora Town Hall
 As discussed in the October Board meeting, Dave Keller obtained quotes for tree services for the Zamora Town Hall. Yolo County Arborists & Evergreen Arborists submitted work proposals for removal of a diseased tree that caught fire last month.
