## 2023 Year in Review

2023, to date, has been a busy, yet steady year. As of 12/19/23, we're at 151 calls, which is down slightly from the previous year (177 at EOY). We had a couple of decent sized grass fires in district, neither of which were negligent. Both were extinguished in a timely manner and the response from Zamora, and neighboring agencies was very timely. Our guys have done a great job and haven't missed any call this year.

We have had one person, Matt Hermle, go honorary this year. We thank him for his many years of dedicated service and wish him the best. We also had Jake Campos go on injured reserve due to an non-fire department incident and wish him a speedy recovery. We have added two new volunteers, Jacob Froman and Zack Greenlee, both of whom live in district. We have the same amount of volunteers as last year at 15.

We also broke ground on a new well for the Zamora Town Hall and Zamora Fire Station. To date, the well is yet to be completed, however the well has been drilled and the casing has been installed. This will be a massive upgrade over the existing the well, which has run it's course and needs to be retired. The new well and pump will decrease water tender fill times from the current 25 minutes when empty to roughly 5-6 minutes. This is a huge advantage to have when fighting large fires that require frequent fills.

Just in the nick of time, we acquired a new apparatus. It is a 2004 Ford Excursion that will be utilized for Chief/Fire Response duties. It was retired from the Yoche Dehe Fire Department fleet and generously donated to us. This will be a huge help in staying safe along the roadway when responding to and on a call. This rig is set up with multiple radios, which is essential in managing large incidents as multiple channels are often utilized.

The comradery amongst the guys has been ever increasing, and I look forward to improving further for the 2024 year.
