developed the CWPP with the Yolo County Fire Safe Council & the Office of Emergency Services with input from CALFIRE, local government agencies and the community. The CWPP is developed to reduce wildfire risk and offer programs for high fire zones.

Ms. Meyer requests Board input on zones in our District that are of high risk. The Board shares that the Eucalyptus grove is of high fire risk and currently has a burn policy in place for this area.

The CWPP offers chipping, defensible space assessments & reflective address signs for high fire zones, the eucalyptus grove could benefit from these programs. Ms. Meyers also suggests "high fire zone" signage in this area. The protection plan will be signed off by the President of the Yolo Co. Fire Chief's Association as well as CALFIRE come 2023.

After presenting the CWPP Ms. Meyer left the meeting.
